Tuition Fees (Primary): The Primary School tuition fee covers the costs of student workbooks and resources for Maths, English (Spelling, Reading Comprehension, Grammar and Writing), History, Science, stationery, the College diary, most excursions including swimming lessons and other incidental costs. It does not cover uniform, camps, and out of town excursions.

Tuition Fees (Secondary): As well as general tuition, this covers all incidental costs including local excursions. This does not cover text books and stationery, uniforms, camps and out of town excursions. A \$460 general subject levy has been added to the Secondary School fee schedule and will be billed in four installments of \$115 per term. An additional subject levy may be incurred for specific subjects, for example, Systems Technology and Food Technology. **Year 12 Fees** will be billed in three equal installments in Terms 1 to 3. VCE Subjects Food Studies and Systems Engineering incur a \$153 levy.

Payments

Payments can be made by cheque, cash, EFTPOS, EFT or Direct Debit. It is the parent's responsibility to make appropriate arrangements in regard to fee payments. Parents that encounter financial difficulties shall be required to make an appointment with the Principal.

Notice of Withdrawal of Student

It is a requirement that a minimum of a term's notice is required for the withdrawal of a student from the College. This notice must be in writing to the Principal.

Enrolment Fee

A non-refundable application fee of \$50 per family is payable with the Application for Enrolment. This fee is retained by the College and applied to the administration costs associated with enrolments.

College Discounts

A 33% discount on school fees will be granted for children of a pastor or children of Kerang Christian College teachers. Any family that has more than three children attending this school the fourth and subsequent children enrolled will be exempt from school fees. The lowest year levels will be exempt.

Fee Accounts

Accounts are issued quarterly at the commencement of each school term. Kerang Christian College is a non-profit organisation, which exists to provide a low fee, Independent Christian Education. Although the College receives State and Commonwealth Government Recurrent Grants we have to operate under financial constraints. Therefore it is imperative that all fees are paid as per 2024 Fees Schedule. Failure to pay on time may place the College in an overdraft situation which penalises all families of the College.
